### 3.1. Who Is Eligible

- (1) a person who donates money, food, equipment or other property to the Society and receives a charitable tax receipt
  - (a) for example, food suppliers or monetary donors
  - (b) this excludes government or private foundation funders
- (2) a person which has constituents, members or stakeholders who individually receive or purchase food directly or indirectly from the Society
  - (a) for example, social service agencies
  - (b) this excludes an individual who is a constituent, customer, stakeholder or end user of services of that person
- (3) a person who submits an application to become a member
- (4) in cases (1) and (2) above, the Society shall send an invitation to the person to become a member upon completion of the first transaction
- (5) in cases (1) and (2) above, where the person is an incorporated organization, an individual affiliated with the person shall be nominated and named in the application for membership
